Higher Education Emergency Relief Funding under the CARES Act Emergency Relief Grants for Students September 30, 2020 – Quarterly and Final Report

On April 10, 2020, Dr. Walt Tribley, President of the Northern Wyoming Community College District, signed a Certification and Agreement for NWCCD's application for the Higher Education Emergency Relief Fund (HEERF) Grant under the CARES Act. As required by the U.S. Secretary of Education, this agreement indicates that our institution will use no less than 50 percent of the funding to provide emergency financial aid to students. NWCCD was awarded the Grant and allocated \$587,680 in funding to be distributed as emergency financial relief grants to students.

As recommended by our auditors and other professionals in the field, NWCCD issued the final disbursement of these grants prior to May 22, 2020, which was the official end of the Spring 2020 term. After the final disbursement was processed on May 20, 2020, NWCCD had distributed a total of \$587,680.80 in Emergency Financial Relief Grants to students as outlined in the table below.

Throughout this process, our staff monitored official guidance from the U.S. Department of Education that continued to be released. As a result, and according to our best interpretation, we first invited students who had already completed a 2019-2020 Free Application for Federal Student Aid (FAFSA) to request funding from the HEERF Grant if they were a high school graduate enrolled in at least six credit hours and working toward a certificate or degree in a Federally-approved program. We had identified 1,051 students who met that initial criteria. A second notice was sent to 422 additional students who met the initial criteria, except for completing the FAFSA, encouraging these students to complete a FAFSA. Later it was determined that the students who had not yet completed a FAFSA could, instead, sign a self-attestation of their eligibility to receive HEERF funding. Of the students who did not complete a FAFSA, we had 57 students complete a self-attestation of their eligibility. In total, students were contacted as many as four times if they did not complete a request for funding.

Once a student requested emergency funds, NWCCD staff verified that the following eligibility requirements were met, before issuing the grant to the student.

Students must have a high school diploma or equivalent (high school students are ineligible).

- Students must be enrolled in a credentialed program (professional development students are ineligible).
- Student must have a valid social security number and be a U.S. citizen.
- Male students must have registered for Selective Service.
- Students who have a completed FAFSA on file for the 2019 Academic Year have demonstrated eligibility. Students who had not completed the FAFSA were asked to sign a self-attestation of their eligibility to receive funding.
- Students who were enrolled fully online prior to COVID-19 (March 13, 2020) disruption are ineligible; this is confirmed by additional guidance released by DOE.
- Students enrolled in 12 credit hours or more will be considered full-time.
- Students enrolled in 6 to 11 credit hours will be considered part-time.
- W's and I's will not count toward full-time or part-time status.
- Attestation by the student of agreement to the use of funds as stated in the law is necessary to prove our compliance and will be provided by filing a request for funding form.
- The "spirit" of the funding is that it be used for those with true financial need.
- Until verified, students must be meeting satisfactory academic progress.

In order to follow our institution's data protection protocols, we sent the full HEERF funding information, with a link to our request form, only to our school's email addresses. To be sure that students were notified, we sent text messages to all identified students using every cell phone number we had on file. The text message, shown below, instructed them to check their school email for additional information. We also sent e-mails to each identified student's non-school email accounts on file, that also directed the students to check their school email.

The amount you receive will be based on your level of enrollment (full or part-time) and the amount of expected family contribution calculated from your FAFSA.

The spirit of the CARES Act is to provide aid as quickly as possible to those who truly need it. With that said, we would encourage you to evaluate your personal situation and consider giving your allocation to those students who have significant need by denying the aid you may be eligible for. You can do so by marking the appropriate response on the request form.

Depending on the number of requests and amount of aid distributed, you could receive additional disbursements from these funds; however, you will only have to submit your request one time.

Distribution schedule:

Submit eligible request by Sunday, May 3rd, distributed Wednesday, May 6th. Submit eligible request by Sunday, May 17th, distributed Wednesday, May 20th. Submit eligible request by Sunday, May 31st, distributed Wednesday, June 3rd.

Payments will be processed on Wednesdays and checks will be mailed on Thursdays. For the fastest receipt, please be sure your mailing address is accurate and sign up for direct deposit.
