
- 1771
 - Virginia Arrests 50 Baptists
- 1798
 - Alien & Sedition Acts
 - John Adams





- 1836
 - Gag Order in the House of Reps
 - Could not talk about abolition of slavery
 - Repealed in 1844
- 1873
 - Comstock Law





- 1917
 - Espionage Act
- 1918
 - Sedition Act





- 1919
 - Schenck vs. United States
- 1919
 - Debs vs. United States
- 1919
 - Abrams vs. United States
- 1925
 - Gitlow vs. New York

- 1940
 - Congress passes the Smith Act, Title I of the Alien Registration Act of 1940
 - Makes it a crime to advocate the violent overthrow of the government.
- 1940
 - o Minersville School District vs. Gobitis
 - Pennsylvania Flag Salute
 - "National unity is the basis of national security."
- 1941
 - Congress authorizes FDR to create the "Office of Censorship."
- 1942
 - Chaplinsky vs. New Hampshire
 - "Fighting Words" Doctrine
 - Your right to swing your fist ends where my nose begins





- 1969
 - Brandenburg vs.Ohio
 - Imminent LawlessAction
- 1973
 - Miller vs. California
 - Obscenity Test

Free Speech Upheld:

- 1937
 - o Dejonge vs. Oregon
 - The Court writes that "peaceable assembly for lawful discussion cannot be made a crime."
 - "The holding of meetings for peaceable political action cannot be proscribed."
- 1969
 - o Tinker vs. Des Moines
 - Students do not shed their constitutional rights at the schoolhouse gate
- 1971
 - New York Times vs. United States
 - Publishing of the Pentagon Papers



Free Speech Upheld:



- 1971
 - Cohen vs. California
 - F the Draft
 - Profanity is Protected Speech
 - Time, Place, & Manner

- 1989
 - Texas vs. Johnson
 - Flag Burning
- 2002
 - Republican Party of Minnesota vs. White
 - Provision prohibiting judicial candidates from announcing their views on disputed legal or political issues violates the First Amendment.
- 2010
 - Citizens United vs. FEC
 - Campaign donations are free speech
 - Opened floodgates of campaign finance
- 2021
- Mahoney vs. BL
 - Student speech off-campus
 - Social Media
 - School Officials

- Social Media
 - 0 X
 - Jack Dorsey vs. ElonMusk
 - Facebook
 - Mark Zuckerberg
 - \$400 million into elections in 2020
- Republican backed lawsuits over banned users concerning "contentious rhetoric"

Free Speech Issues Today: Cancel Culture



- Cancel Culture
- What does the research say?
 - 58%
 - o 38%
- How does politics affect cancel culture?
 - Democrats:
 - 75% vs. 39%
 - Republicans:
 - 56% vs. 22%

Free Speech Issues Today: Covid-19

- Misinformation & Fact Checking
 - Several countries have criminalized vaccine misinformation, but the United States has not.
 - Has the Supreme Court's interpretation of the First Amendment allowed the continued spread of false claims?
 - US vs. Alvarez 2012
 - Impact?




Free Speech Issues Today: Jawboning


- Jawboning

 - Speak about things that might be considered taboo- thus prompting censorship
