2026 NWCCD ADN ADMISSION REQUIREMENTS

PREREQUISITES: Prerequisites can be taken at any accredited college or university and include:

- ENGL 1010 English I (3 credits)
- MATH 1000 Problem Solving (3 credits), MATH 1400 College Algebra (4 credits) or equivalent.
 Equivalent classes include MATH 1405 Trigonometry, MATH 1450 Algebra and Trigonometry, MATH 2200 Calculus I, MATH 2205 Calculus II, MATH 2210 Calculus III
- BIOL 1010 General Biology 1 (4 credits) or equivalent (BIOL 1000)
- ZOO 2010 Human Anatomy & Physiology I with Lab (4 credits)

Prerequisite courses must be completed with a grade of C or higher prior to application to the program in order to receive points towards your application. Grades of passing (P) or satisfactory (S) for pre-requisite classes will receive full points towards nursing application rank.

Student applicants may be concurrently enrolled in up to two (2) of the four (4) pre-requisite courses and apply. Points will be awarded for completed pre-requisite courses only, and zero (0) points will be received for the unfinished courses. If offered a seat in the program, final acceptance is contingent on successful completion of the concurrently enrolled pre-requisite course with a grade of "C" or better by the end of the spring semester. Pre-requisite courses must be complete and verified by an official transcript by June 1.

Students who wish to transfer college-level credit from other schools must submit all official transcripts to the Records office. Coursework completed at another institution does not guarantee a direct equivalency at NWCCD. Once transcripts are received courses are evaluated based upon the content completed and the Records office issues a Transfer Equivalency Report (TRER) which may be accessed by the student through the NWCCD self-service portal.

Passing CLEP or Advanced Placement (AP) scores are accepted in lieu of coursework for required ADN courses per NWCCD policies. Items must be officially submitted and accepted by the Records office for use/acceptance by the Nursing Program. Official CLEP and AP transcripts can be requested from CollegeBoard.org.

Applicant must be a high school graduate or equivalent. Documentation of graduation from high school or college in the form of a valid high school diploma or higher earned degree, transcript, or other acceptable documentation confirming the applicant meets or exceeds the academic achievement equivalent to a high school diploma. Students may apply while still enrolled in their final semester of high school; however full acceptance is contingent upon receipt of documentation indicating completion.

GPA: A minimum college GPA of 2.5 is required. All completed courses applicable to the Associate Degree in Nursing will be used to compute GPA, including pre-requisites and co-requisites. All courses must be completed with a grade of C or higher.

HESI ADMISSION ASSESSMENT EXAM: Applicants must take the HESI Admission Assessment (HESI A2) exam as part of the nursing program application process. The assessment must be taken prior to the March 1 application deadline and an individual total score of 75% or higher must be achieved. The HESI A2 may be repeated once (must wait 14 days between tests) between March 2 and March 1 for score improvement. Only passing scores achieved by the March 1 application deadline in the current admission cycle will be considered. The higher of the two scores is used.

NURSING APPLICATION: Submit nursing application for admission to the Sheridan College Nursing Program. This is a separate application from the general NWCCD application. Complete the Nursing Program Application at https://www.sheridan.edu/academics/programs-a-z/nursing/.

DEADLINE: The nursing application deadline is **March 1** for admission in the fall semester. Late applications and transcripts will not be reviewed. Once the application is submitted, it is the applicant's responsibility to contact the Nursing office at the college to confirm receipt.

SELECTION PROCESS

Acceptance to the program is competitive and applicants are evaluated based on a three-tier system. Each year approximately 64 students combined are selected to enter the program on the Sheridan campus at the branch campus in Gillette. Applicants are ranked in order according to total points.

TIER I: Application Evaluation and Ranking

Applicants are evaluated using a point system. Points are earned in the following two areas:

- 1. Pre-requisite points: points are awarded for the letter grades earned in the pre-requisite classes as follows: A or S = 4 points, B = 3 points, C = 2 points.
- 2. HESI A2 cumulative score: a score of 75% or higher must be achieved for program admission eligibility.

The total pre-requisite points achieved (up to 16 points possible) are added to the higher HESI A2 score to determine overall ranking. Applicants with the highest points are offered a seat in the program.

TIER II: Seat Deposit and Conditional Acceptance

Once offered a seat in the program, submit a signed Acceptance or Declination Form indicating intention. If accepting, a \$250.00 non-refundable deposit to hold your seat in the program is due by the annual program-designated date.

TIER III: Post Selection Requirements

Full admission is awarded upon successful completion of various requirements, which may include but are not limited to the following: background screening, drug screen, and documentation of the following: health examination and required immunizations, and AHA Providers Basic Life Support certification (CPR). A complete list of these requirements and instructions are provided following notification of acceptance and receipt of the deposit. NOTE: Failure to complete the post-selection requirements by the assigned due dates will result in a rescinded admission offer and loss of seat deposit.

BACKGROUND FINDINGS: Applicants with questions or concerns regarding future licensure based on results of the criminal background check or drug screen should contact the Wyoming State Board of Nursing at 307-777-7601. Admission to the nursing program is not a guarantee of professional licensure.

NOTIFICATION: All applicants are notified of acceptance decisions approximately 4 weeks after application deadline. Applicants will receive an email with notice of acceptance to the program, placement on the alternate list, or non-acceptance. An alternate list is maintained in the event an applicant declines acceptance. Students placed on the alternate list will be notified in the order of their ranking should an opening occur in the current admission cycle.

ReNEW Nursing Curriculum

This four-semester program (after completion of the necessary prerequisites and acceptance into the program) is part of the statewide nursing curriculum Revolutionizing Nursing Education in Wyoming (ReNEW) which is designed as a baccalaureate curriculum with an ADN benchmark allowing students to sit for the NCLEX-RN (licensure exam) at the completion of the fourth semester. This curriculum allows students to complete an Associate Degree in Nursing, gain RN licensure and employment, and then transition seamlessly into the University of Wyoming for their senior year and complete a bachelor's degree.

The curriculum includes a balance of general education and nursing courses that assist students in acquiring the knowledge and skills to function as beginning practitioners of nursing. Students receive classroom instruction and coordinated clinical experience in the nursing care of patients in health care settings under the supervision and guidance of the nursing faculty. Clinical sites are in a variety of settings and travel may be required.

The nursing curriculum at Northern Wyoming Community College District is a leveled educational program to facilitate career mobility. The first two semesters provide a foundation for progression in the field of nursing and prepare the student to enter the second level of the nursing curriculum. At this point, after completion of the prerequisites and the first two semesters of the program, a student may choose to take the optional Practical Nursing Roles course which will give them the ability to earn a certificate and provide eligibility to take the National Council Licensure Exam (NCLEXPN) and attain licensure as a Licensed Practical Nurse (LPN).

Upon completion of the 2-year program, the graduate earns an Associate Degree in Nursing (ADN) and is eligible to take the National Council Licensure Exam (NCLEX-RN) and attain licensure as a Registered Nurse. Prerequisite courses must be completed with a grade of "C" or better. Students are encouraged to contact the Nursing department directly for program-specific questions. Current Nursing students should refer to the respective catalog in which they began the Nursing program. Admission to the NWCCD Nursing Program is competitive and students must be in satisfactory academic standing with a minimum cumulative GPA of 2.5 or higher for the nursing curriculum.

Revolutionizing Nursing Education in Wyoming (ReNEW) Common Statement: More and more nurses are completing their baccalaureate degree in nursing (BSN) in order to enhance their employment opportunities, facilitate career advancement and/or prepare for graduate education. ReNEW is a shared statewide curriculum providing a streamlined bridge from the associate degree in nursing to the BSN

The ReNEW program plan is a four-year, eight semester baccalaureate curriculum.

- You can start at one of the Wyoming community colleges and be dually enrolled at the University of Wyoming.
- Upon successful completion of the five-semester ADN benchmark, you are awarded an associate degree in nursing. Upon completion of the eight semesters, the BSN degree is awarded.
- The courses/clinical experiences needed to complete the BSN in year four are available through the university online so you do not have to leave home.
- NWCCD began the ReNEW curriculum August 2018.

HESI Admission Assessment Exam



With the HESI Admission Assessment Exam, you can test program applicants in three main academic areas — English Language, Math, Science — and two personal assessment areas. By gauging students' academic readiness and identifying learning and personality styles, you'll be able to admit the best prospective students to your nursing program.

ENGLISH LANGUAGE (Each exam includes 55 test items - 50 scored and 5 pilot)

Reading Comprehension

Provides reading scenarios in order to measure reading comprehension, identifying the main idea, finding meaning of words in context, passage comprehension, making logical inferences, etc.

Recommended time: 60 minutes

Vocabulary and General Knowledge

Contains vocabulary terms that are commonly used in both general English-speaking settings and in health care fields.

Recommended time: 50 minutes

Grammar

Contains basic grammar, including parts of speech, important terms and their uses, commonly occurring grammatical errors, etc. *Recommended time: 50 minutes*

MATH (Exam includes 55 test items - 50 scored and 5 pilot)

Basic Math Skills

Focuses on math skills needed for health care fields, including basic addition, subtraction, multiplication, fractions, decimals,

ratio and proportion, household measures, general math facts, etc. Recommended time: 50 minutes

SCIENCE (Each exam includes 30 test items - 25 scored and 5 pilot)

Anatomy and Physiology

Provides coverage of general terminology and anatomical structures and systems. *Recommended time: 25 minutes*

REPORTING

Detailed diagnostic reports are provided for both prospective students and educators. Institutional summary reports are prepared for every school that administers the exam that includes composite scores, subject-area composite scores, and percentage scores. Individual student reports include scoring explanations and missed questions by topic for the Reading Comprehension, Vocabulary and General Knowledge, Grammar, and Basic Math Skills questions.

Peer-reviewed research findings* indicate HESI Admission Assessment scores are valid predictors of student success and can therefore assist educators in the selection process and assist students in identifying and remediating academic weaknesses prior to entering a program.

HESI ADMISSION ASSESSMENT (A2) EXAM FAQs

What is the HESI Admission Assessment (A2) Exam? The HESI Admission Assessment, or HESI A2, is a computerized exam designed to assess the academic readiness of prospective students for higher education. Learn more <u>HESI - Elsevier Student Life</u>.


Where can I take the HESI A2 exam? The Sheridan College Testing Center offers HESI Admission Assessment (HESI A2) testing in the Kooi Library located in the Griffith Memorial Building on the Sheridan Campus. Contact the Nursing Coordinator for scheduling instructions. Exams must be scheduled a minimum of 2 business days in advance of the desired test date.

What does the HESI A2 cost? The exam is \$75.00 and is paid at the Testing Center.

What should I bring with me? Bring only photo identification. Testing supplies will be issued, including paper and pencil. A basic calculator is provided. Lockers are provided for personal items. Students will be permitted short breaks if needed. Total time allotted to complete the exam is 6 hours.

How should I prepare? Elsevier publishes review materials for this exam that may be purchased directly through Elsevier or through your local bookstore. In addition, the study booklet, Admission Assessment Exam Review (Elsevier Health Services), may be available for check out at the college library. What is the passing score? In order to meet eligibility requirements students must achieve an overall cumulative score of 75% Admission to the Nursing Program is highly competitive and is not guaranteed even if you meet a grade or test score criteria. Each applicant is evaluated on the strength of the credentials presented and judged against equally strong applicants. The higher your score, the stronger your application becomes. Official scores are obtained directly from Elsevier. Score results must be within the 12 month period up until the posted deadline—March 1st each year. Score results after this deadline will be considered for the next year's admission cycle.

What if I don't pass the HESI A2 the first time? Students have the option to retake the test one time within a 12 month timeframe. Students must wait 14 days between attempts. The HESI entrance exam scores must be less than one year old from the March 1 deadline of the current year. Scores from tests taken in violation of the 14 day rule are invalid. The Nursing Program will use the higher score to determine eligibility and ranking for acceptance.
