  - a. Watt Foundation Board of Directors Both NWCCD and SCF Boards posed for a photo in the TRCC at the beginning of the meeting.
- 4. Report from Sheridan College Sheridan College President, Dr. Walt Tribley Chair Swanson welcomed both Boards. Dr. Tribley gave a brief presentation on the Big Horn Mountain Advantage Program describing it as a scholarship for the portion of tuition typically charged for non-Wyoming residents. He thanked the Foundation for raising funds for housing scholarships. He described the work being done to implement the SC Strategic Plan 2030 through goals and initiatives.
- **5. Economic Value of Sheridan College** Dr. Walt Tribley & AVP Rob Briggs AVP Briggs gave a presentation on the study conducted by Lightcast on the economic value of SC to the students and communities it serves.

  - ii. Scholarship Process Review VP Crouse described the process by which the SCF awards scholarships to students. Students fill out one application to be considered for all available scholarships, and they are awarded scholarships based on eligibility criteria.
