## Dental Hygiene Program General Information

The dental hygienist is a preventive oral care professional who is licensed to provide educational, clinical, and therapeutic dental hygiene services to the public. Full-time, part-time, evening, and weekend work is widely available. Earnings vary by geographic location, employment settings, and years of experience. Dental hygienists have the opportunity to work in a variety of settings including private dental offices, dental clinics, federal, state, or local health departments, hospitals, nursing homes, school districts, correctional facilities, private industry, or as educators, researchers, and administrators. The variety of career opportunities and the possibility of flexible hours and schedules make dental hygiene an attractive career choice.

Graduates will also be competent in the use of laser for soft tissue laser therapy, and administration of both local anesthesia and nitrous oxide/oxygen administration. Applicants are encouraged to contact the State Board of Dentistry in the states in which they wish to practice for individual licensing requirements.

#### DENTAL HYGIENE PROGRAM MISSION

Sheridan College Dental Hygiene Program graduates will be competent dental hygienists who uphold professional and ethical standards through critical-thinking, evidence-based decision making. They will demonstrate empathy and compassion when providing care to diverse populations and strive to be effective team members. They will be conscientious, life-long learners who actively participate in their communities and the dental hygiene profession.

#### **PROGRAM OUTCOMES**

- Established expectations that identify exit-level occupational or discipline-specific skills and abilities which are assessed prior to earning a credential.
- **1.** Apply a professional code of ethics in all endeavors, assuming responsibility for professional actions.
- 2. Promote positive values of overall health and wellness, in a culturally competent manner, to individuals, the public, and organizations within and outside the profession.
- **3.** Assess the oral health needs and services of community groups, determine action plans, and evaluate the outcomes of community-based programs.
- 4. Provide individualized care utilizing the dental hygiene process of care model (assessment, dental hygiene diagnosis, planning, implementation, evaluation, documentation) that includes the educational, preventive, and therapeutic services necessary to achieve and maintain oral health.
- 5. Accept responsibility for continuous professional growth through self-assessment, pursuit of life-long learning, and service activities.

#### STUDENT COMMITMENT

Due to the demands of the full-time dental hygiene program, student employment is not encouraged. This personal decision should be based on individual performance in the classroom, clinical sites, and personal health. It is the desire of the dental hygiene faculty that students be successful in the program and that essential learning is not compromised. Students will not be excused from class or clinical assignments for personal work schedules.

Clinical, laboratory, and program activities in the SC clinic and other external sites may be scheduled as early as 7 am or as late as 10 pm and may be on any day of the week. Students are required to participate in these activities as scheduled. Childcare arrangements, work schedules, and transportation are the students' responsibility.

Classroom, laboratory, and service-learning attendance are expected. Accountability for knowledge and assignments is the student's responsibility. Failure to comply with attendance or assignments may interfere with progression in the program and could result in dismissal from the program.

Dental hygienists must possess clinical skills. This skill development takes time and practice. Students are given clinic time to develop these skills and must see a sufficient number of patients for skill development to occur. The clinic provides a small number of patients to the student, but a majority of patient appointments are scheduled by the student. This can be a time-consuming process, so expect to spend some hours per week looking for and scheduling the patients needed to develop specific skills.

The dental hygiene profession from its inception has been built on a foundation of prevention. As dental hygiene professionals, we must advocate for disease prevention and public health. Prevention includes vaccinations, sealants, and fluoride therapies. The expectation of the Dental Hygiene Program is that students will participate in all learning activities including promoting prevention.

#### PROGRESSION IN THE PROGRAM

To progress in the dental hygiene program, the student must:

- 1. Maintain a minimum grade of "C" in each required dental hygiene course.
- 2. Maintain acceptable background checks/drug screens and certifications.
- 3. Meet attendance requirements in clinical, lab, and program activities.

To be considered for graduation, all students must demonstrate competency in all facets of the dental hygiene curriculum as set forth by the Commission on Dental Accreditation of the American Dental Association.

#### REQUIREMENTS OF THE STUDENTS IN THE DENTAL HYGIENE PROGRAM

The following is used as a guideline for the prospective students so that they may understand the physical requirements and essential job functions necessary for successful completion of the Dental Hygiene Program. This list is not intended to be all-inclusive, but rather a detail of the basic demands of the profession of dental hygiene.

- 1. Understand the importance of and be able to wear the appropriate personal protective equipment required to work safely (scrub top, scrub pants, closed-toed shoes, gloves, masks, gowns, etc.).
- 2. Sit, stand and/or bend for extended periods of time in one location with minimal or no breaks.
- 3. Bend, twist, and lift a minimum of 20 pounds.
- 4. Demonstrate sufficient visual ability to instrument and provide anesthesia in the oral cavity with or without corrective lenses and while wearing protective eyewear.
- 5. Demonstrate sufficient peripheral vision to function in the clinical setting.
- 6. Demonstrate sufficient ability to communicate with patients, staff, and instructors while wearing dental masks during clinical treatment with or without accommodations.
- 7. Detect odors sufficient to maintain environmental safety and patient needs.
- 8. Manipulate small instruments, supplies, and equipment with efficiency, dexterity, and exceptional eye-hand coordination.
- 9. Tolerate the sight/smell of blood and body fluids.

- 10. Assist with and/or lift, move, position, and manipulate with or without assistive devices, the non-ambulatory patient.
- 11. Fluently communicate and understand English both verbally and in writing. Bilingual abilities are a plus.
- 12. Be free of reportable communicable diseases and chemical abuse.
- 13. Function without allergic reaction in an environment with substantial latex and chemical exposure.
- 14. Abide by clinical rotation policies and guidelines.
- 15. Provide documentation of immunity set forth by current public health agency guidelines.
- 16. Possess short and long-term memory sufficient to perform tasks such as, but not limited to patient assessment, clinical procedures, professional judgment, and performing anticipation skills in the clinical environment.
- 17. Adhere to a schedule while working under pressure and demonstrate appropriate use of positive coping skills while under stress.
- 18. Exhibit positive interpersonal communication skills in patient, staff, and faculty interactions.
- 19. Make appropriate judgment decisions.

#### **ADMISSIONS CRITERIA**

The dental hygiene education curriculum is scientifically oriented, rigorous, and intensive. Admissions criteria and procedures are necessary to ensure that the students selected have the potential for successful completion of the program. The following page contains the rubric for ranking applicants.

They must complete all the pre-requisite courses listed on the following page, by the end of the spring semester they apply to the program. A maximum of two pre-requisite courses may be in progress in the spring semester that the student applies. Applications and all required materials (transcripts & observation hours) are due **February 15**<sup>th</sup> for the Fall Semester entry.

Pre-requisite courses must be completed with a "C" or better and applicants must have a cumulative GPA of 3.0 to apply for admission. Admission selection is based on cumulative GPA of the non-science pre-requisite courses and cumulative GPA of the science courses pre-requisite courses. All pre-req courses must be completed by the end of the **SPRING** semester in which the student applies. No **SUMMER** course grades are accepted for the summer following the student's application!

Wyoming residents applying to the program will receive 1 preference point in the scoring (see rubric).

Students who take **ALL** 12 pre-requisites at Sheridan College will receive 1 preference point in the scoring (see rubric).

For courses that have been retaken, the most recent grade will be used. A 1 point deduction will occur after two attempts of the **SAME** course.

After the Total Value Points without interview points are determined (see rubric) and if two applicants are equally qualified, then the overall prerequisite GPA will be the determining factor in the selection process. If there is still a tie, the science GPA will be the determining factor. If there is still a tie, the non-science GPA will be the determining factor.

Class size is limited to 24 due to facility capacity. The 24 highest-ranking candidates are offered positions in the program. All other qualified applicants are placed on the Alternate List and may be offered a position in the class should an initially accepted candidate decline the position.

(Being placed on the Alternate List does not guarantee admission.) Applicants must also complete 20 hours of observation of a dental hygienist in a dental facility (form provided). The observation hours may be waived if an applicant has dental assisting experience (waiver form provided).

### **Dental Hygiene Admissions Rubric**

The non-science GPA and science GPA points are totaled together first, the Wyoming residency point is added, the Sheridan College pre-requisite point is added, retake points are deducted, and then the interview points are added for the total score.

Students who score the highest total points after the deductions will have a position in the top tier of applicants. The interview is only offered to the top tier of applicants and the points are added after the interviews are completed to get the overall point scores.

Example: Student with a Non-Science GPA of 3.50 and a Science GPA of 3.65 with 1 retake, who took ALL their pre-requisites at Sheridan College, and scored 15 points on the interview.

#### APPLICATION PROCESS

The dental hygiene program provides an online application for student convenience on the dental hygiene page at <a href="https://www.sheridan.edu/academics/programs-a-z/dental-hygiene/">https://www.sheridan.edu/academics/programs-a-z/dental-hygiene/</a> All applications, transcripts, and forms must be completed by **February 15** to be considered for Fall Semester admittance to the dental hygiene program. All pre-req courses must be completed by the end of the spring semester that the student applies – we do not wait for SUMMER course grades!

<u>Step 1</u>. Apply to Sheridan College on the college webpage, <u>www.sheridan.edu</u> (if not a current Sheridan College student).

<u>Step 2</u>. Official transcripts from your high school and all colleges you have attended must be <u>received by</u> Sheridan College by the application deadline of **February 15**. Official transcripts can be requested and sent electronically through the National Student Clearinghouse at <a href="https://studentclearinghouse.org">https://studentclearinghouse.org</a>.

<u>Step 3</u>. Complete the dental hygiene program application form on the <u>www.sheridan.edu</u> website on the Dental Hygiene page.

<u>Step 4</u>. Submit observation form or observation waiver form to the dental hygiene program by mail, fax, email, or by uploading in the dental hygiene program application.

After February 15, the dental hygiene admissions committee meets to review applications. The top tier of applicants will be contacted to schedule an interview. These interviews are conducted via ZOOM or other such technology between February 15 and March 15. In late March, applicants are notified of their status. Following are the terms and definitions used by the Sheridan College dental hygiene department.

ACCEPTANCE: Applicant has completed all pre-requisites courses, all required forms and materials have been received by the department.

CONDITIONAL ACCEPTANCE: Applicant is currently enrolled in spring semester prerequisite courses and anticipates successful completion. All transcripts up to spring semester have been received, and all other application materials have been received. Conditional acceptance automatically converts to ACCEPTANCE when final spring semester transcripts have been received and courses have been completed successfully.

ALTERNATE ACCEPTANCE: Applicant has completed or is in the process of completing all pre-requisite courses with anticipated successful completion and all other required forms have been received. The ranked score did not place the applicant in the top 24. Alternate candidates are informed of their rank on the list of alternates. If a candidate who is accepted declines the position in the class, the first alternate on the list will be contacted and offered acceptance. This process continues throughout the summer until the first day of fall semester.

#### ADDITIONAL INFORMATION FOR ADMITTED STUDENTS

After admission and prior to entering the class in the fall semester, students are required to complete the following. A letter detailing these requirements is sent to admitted students in May.

<u>CPR</u>- Students are required to be certified in CPR by the American Heart Association at the Basic Life Support (BLS) level for healthcare providers before they begin their first fall semester. All students will need to be certified for the entire two years of the program and through the month of May following graduation.

<u>Criminal Background check</u>- Completed online through the University of Wyoming. A link will be provided to accepted students. Some misdemeanor and/or felony charges would prevent individuals from obtaining licensure. Background checks are completed to ensure potential students are eligible for licensure prior to starting school.

<u>Eye Examination Report</u>- the student will need to have an Eye Examination Report completed (form supplied after acceptance to the program) by an optometrist or physician who provides eye examinations.

<u>Immunizations</u>- As health professionals, dental hygienists, and other dental team members are exposed to contagious diseases, and are therefore, at risk of becoming infected. The National Health Institute, the Centers for Disease Control, and the Department of Health and Human Services all strongly recommend that vaccinations be utilized by health professionals at high risk. Dentists and dental hygienists are near the top of the list of those persons more likely to contract certain diseases. The guidelines for immunizations are established in compliance with the Centers for Disease Control (CDC) and Occupational Safety and Health Act (OSHA). Dental hygiene students are required to have the following immunizations:

- 1. MMR (measles, mumps, rubella) 2 doses in lifetime or positive titer
- 2. Hepatitis B Series must have started the series by program start date
- 3. Tetanus/Diphtheria/Pertussis or Tdap within last 10 years while in the program
- 4. **Tuberculosis (TB)** One of the following must be completed within the past 12 months. We do accept the blood tests listed below in place of the skin testing.
  - Negative 2-step TB skin test (administered 1-3 weeks apart). 2-step TB test means you
    must have 2 separate tests that will take 4 trips to the provider.
    OR
  - Negative QuantiFERON Gold blood test OR
  - Negative IGRA blood test
- 5. Varicella (chicken pox) –Two doses or positive titer
- 6. **Influenza\*** Flu shots become available shortly after the fall semester begins. Plan to get one each year you are in the program (required for outside clinical rotation sites)
- 7. **COVID-19\*** not mandatory for the program but highly encouraged (required for outside clinical rotation sites)
- \*Per outside rotation site policies, students must be vaccinated to attend

<u>Laptop computer</u>- Admitted students are required to have a laptop computer for use during the school year. The minimum standards and recommendations include: wireless connection enabled, ability to access the learning management system online, and a minimum of four hours battery power. Charging stations are available in some classrooms. A home printer is highly recommended. Microsoft Office programs are used extensively in the program. Students must have Word, Excel, PowerPoint, and Outlook. **See Minimum System Requirements on the following page.** 

NOTE: All students must comply with the network acceptable rules of use.

Orientation- The dental hygiene program schedules an orientation session prior to the beginning of fall semester, typically in the first half of August. In addition, students who are new to Sheridan College (i.e. completed their pre-requisites at a different college) will be required to complete an online orientation session.

<u>Student Health Record</u>- As part of the Student Health Record, the student will need to complete the Physical Examination and Health And Safety Guidelines Essential Skills, Abilities, And Performance Standards forms (supplied after acceptance to the program) by their healthcare provider.

#### **Minimum System Requirements for Laptops**

Operating space is needed for students to download the testing software, Examplify.

#### **Windows PC Requirements:**

- Operating System: 64-bit Versions of Windows 10 and Windows 11 (Alternate versions of Windows 10 and Windows 11, such as Windows RT and Windows 10 and 11 S, are NOT supported at this time) (Only genuine versions of Windows Operating Systems are supported).
  - o If you are using a Microsoft Surface device, Windows 10 or 11 "S mode" is **not** compatible with Examplify, only the standard Windows 10 and 11.
