1.) Call to Order and Roll Call

Board Chair Norleen Healy called the January 17, 2019 Regular Meeting of the Board of Trustees to order at 6:32 p.m. Roll was taken and there was a quorum.

2.) Agenda Additions / Deletions - There were none.

3.) Consent Agenda

Chair Norleen Healy asked if everyone had reviewed the Consent Agenda. The Consent Agenda was accepted unanimously.

4.) President's Report - Dr. Paul R. Young

Dr. Paul Young introduced the new Farrier instructor, Quint Gonzales. Mr. Gonzales brings 19 years of shoeing experience in Buffalo and assisted a former instructor at Sheridan College. The program already has 7 out of 8 (class maximum) students enrolled for the farrier program. Dr. Young also notified the Board of computer instructor, Mark Thoney, receiving a national award for his "app" work with Buffalo High School students. He recognized Excellence Award recipients. He then opened the floor to Chief of Campus Police, Jason Vela, to discuss SF 75, gun legislation. Chief Vela informed the Board of the potential affect that this bill would have on school campuses. Treasurer Leibrich was concerned about the loss of local authority in passing this bill. No action was taken.

5.) Gillette College Advisory Board Report - Tracy Wasserburger, Chair

Chair Tracy Wasserburger joined by video-conference. VP Janell Oberlander provided a report. Janell shared good news regarding two Gillette nursing faculty: Gwen Reed passed the national certification exam distinguishing her as a Certified Nurse Educator from the National League of Nursing. This is the ultimate mark of excellence for nurse educators.

Julie Guernsey received notice on her national appointment to assist with review and share her expertise with the Low Risk Neonatal Nursing Exam for national certification for registered nurses. She will assist with analyzing exam specifications, collaborate on new standards for the field, and assist with writing test items. She will travel to Chicago in April as a part of this appointment and the expertise involved.

Johnson County Advisory Board Report - Jack Tarter, Chair

Chair Jack Tarter updated the Board that Class 5 of Leadership Johnson County has started. He mentioned Casper getting the Veterans' Home modeled after Greenhouse living and thanked Dr. Young and College Administration for their support.

Sheridan College Foundation Report – Executive Director Jen Crouse highlighted the success of the two Foundation campaigns that resulted in over \$45,000 more raised for scholarships over last year's fundraising. Nominations for Distinguished Alumni are now being taken. There will be an "Alumnight" at the Sheridan vs. Gillette basketball games on Wednesday, January 23, 2019.
