- 1. Call to Order and Roll Call Regular Meeting
  Chair Wendtland called the meeting to order at 6:31 p.m. There was a quorum.
- 2. Pledge of Allegiance

### 3. Agenda Additions/Deletions

Chair Wendtland asked for changes or corrections to the consent agenda. There were none. She requested a motion to approve the consent agenda as presented. Trustee Healy moved, and Trustee Swanson seconded. There was no further discussion. The motion carried.

# 5. President's Report - Dr. Walt Tribley

- a. COVID-19 Dr. Tribley reported that there are no significant updates, and cases remain low.
- b. District Division Update The Presidents, Transition Teams for NWCCD and GCCD, and mediator Mark Gifford plan to meet on 9-22-2022 to get an update on where GCCD stands in relation to their accreditation process. They also plan to discuss intellectual property, revenue and cost sharing, and information technology.
- c. General Updates Dr. Tribley complimented the new SC marketing materials, which were provided to the Trustees. He highlighted the Whitney Days schedule including the Pat Hamilton memorial rodeo and upcoming WCA events. He gave a brief update on the Wyoming Innovation Partnership and the progress made on the new advanced manufacturing facility planning.

# 6. Johnson County Advisory Board Report – Cindy Kremers, Chair

Ms. Kremers reported that the SCJC Advisory Board continues to recruit new members. In partnership with the Johnson County library, SCJC plans to present three music ensembles this fall, which will be free for the community. JCSD #1 requested assistance in hosting financial aid nights for students and parents to hear information on the FASFA application and scholarship opportunities.

# Sheridan College Foundation Report – Jennifer Crouse, Executive Director

VP Crouse reported great success this summer at the Third Thursday street festival appearances. The foundation was present along with the rodeo team and were able to reach out to the community. She promoted the Whitney Days events. The SCF annual report is nearing completion. Donor will receive the final report. The annual audit is underway. The SCF having special meetings with financial committee as the market fluctuates.

# 7. Organization Reports

a. Faculty Senate – Mark Thoney, President

Mr. Thoney reported that the governance groups have just had their first meeting of the semester. Faculty Senate, as a result of the division, have begun work on revising the constitution and bylaws, as they did not address a circumstance such as the District dividing into two. This will be their main task for this academic year. The same five elected senators represent SC this year, with elections for new senators to occur in the spring.

# b. Student Government Association (SGA) - Rachael Simons, SGA President

Ms. Simons reported SGA's top six priorities for the semester: recruiting new student senators, hammock village on campus for student use, UW representative/liaison on campus or available by Zoom to assist students with dual enrollment and/or transfer, promoting MyVoice, pronouns and preferred names on emails and other college documents, and Generals Thrift store on campus for students.

- **8. Public Comments** Trustee Koltiska asked about the SC Pat Hamilton Memorial Rodeo. Dr. Tribley provided more information on the rodeo and offered to email details to the Trustees.
- 9. Key Monitoring Reports

a. Enrollment Report – Dr. Tribley and AVP Briggs provided a detailed enrollment report to the Trustees. The report focused on current enrollment captured at 14 days after the start of the current term. AVP Briggs also presented historical data for reference and comparison. At this point, enrollment for the current semester is up over recent, previous years. Dual and concurrent enrollment has not yet been fully reported. Final numbers for the semester are forthcoming.
