**a. Dual and Concurrent Enrollment – Update with Handout**

Assistant Superintendent Craft provided an update on the status of dual and concurrent enrollment. Dual and concurrent enrollment allows Sheridan high school students the opportunity to earn college credit from Sheridan College while still in high school. It is an efficient way to earn college credits, and the program continues to grow and support students in Sheridan County.

**b. Fifth Street Property Update – Presentation and Discussion**

Superintendent Stults and Assistant Superintendent Craft described the generous gift given by Scotty & Janet Scott to SCSD #2 allowing for the purchase of the Holly Seed property on 5<sup>th</sup> Street in Sheridan, adjacent to Sheridan High School. Mr. Craft presented the process by which SCSD #2 gathered information and determined two possible uses for the property to address community interests and needs. The options include a career development center and a multi-use community center. Next steps include continued work with community stakeholders and determining funding sources to make the most of this opportunity.
